To the extent possible, graduate students are supported in the form of a graduate assistantship. An assistantship grants the student a tuition waiver and a monthly stipend. Students with assistantships provide service to their advisor through a combination of research and teaching activities. Typically, assistantships are funded by research projects directed by individual faculty members. Limited support may be provided by the department in the form of teaching assistantships. In these cases, students assist with laboratory sections or other aspects of an EHS class.
